- a. Conduct two Continuous Internal Evaluation (CIE) instead of three CIE
- b. Conduct One Compensatory CIE for Absentees as per the regulations.

- c. Give more weightage in total CIE for the students who complete courses in NPTEL /Coursera.
- d. Give an option for fast learners to take additional 8 credits from higher semester courses.
- e. For 1st year engineering integrated courses mandate to set questions in Semester End Exam (SEE) on the lab component.
- f. Conduct practical SEE for integrated courses of higher semester.

- a. Mention only Paper Setting Board (PSB) in the scheme
- b. Mathematics course should be added for Mechanical and Civil stream up to third semester.
- c. Higher Engineering Mathematics / Physics / Chemistry courses can also be offered as an elective in the higher semesters.
- d. Respective engineering department faculty should teach a module containing the applications of Mathematics.
- e. For any Emerging Technology Courses (ETC) prerequisites are very important; make use of virtual labs to encourage the students for understanding the concepts of ETC.
- f. Include Sustainable Engineering as an ETC.
- g. Follow the course codes defined by VTU for the scheme of MBA.
- h. Either seminars / workshops / elective courses can be offered about the Leadership and Strategic Management.
- i. Technical writing and documentation with regulations can be included in higher semester courses.
